Notes:

1. Students will be informed by their respective College on the specific modules to read, after admission into the UTCP. Generally the sequences are interchangeable, except that Ideas and Exposition (I&E I) must be read before Ideas & Exposition II (I&E II).

2. Students are expected to read one UTCP module per year to fulfil the College residency requirement. Residency in the second year is subject to Law Vice Dean (Academic Affairs)'s approval for the students to read a second UTCP module as Enrichment. Students can seek approval by submitting their requests to lawundergrad@nus.edu.sg.

Enrichment = The grade will be reflected on the transcript but the module will not count towards fulfilling the credits required to complete the LL.B. degree. Nor will the grades and marks be used for the calculation of Class of Honours. Students will be required to inform Law's Academic Affairs Office should they be reading Non-Law module for enrichment.

3. Students should consult their respective College for advice on participating in the Student Exchange Programme during their College residency.

4. Students admitted to UTCP as freshmen are given up to two years of residency but can apply to their respective College to be retained for a third year.
