Joseph CHUN is an Adjunct Associate Professor at the NUS Law Faculty and an Associate Member of the Asia Pacific Centre for Environmental Law (APCEL). He has been teaching the environmental law module in the Bachelor of Environmental Studies programme since 2013, and will begin co-teaching the environmental law module in the MSc (Environmental Management) [MEM] programme starting this coming semester. He has written on a range of topics within environmental law, including nature conservation and wildlife protection law in Singapore; environmental analysis of real estate law; and the public trust doctrine in Singapore. On an ad hoc basis, he also volunteers his legal support to green civil society groups, including the Nature Society of Singapore. Joseph graduated with an LLB (Hons) from NUS in 1991 and a PhD in Laws from University College London in 2003.



LYE Lin-Heng is Director of the Asia-Pacific Centre for Environmental Law (APCEL), Faculty of Law, National University of Singapore (NUS), and former Vice-Dean. She teaches and researches on environmental law in NUS and at the Yale School of Forestry & Environmental Studies. She chairs the NUS multi-disciplinary graduate programme on the environment, the M.Sc. (Environmental Management) [MEM], hosted by the School of Design & Environment.

She was former Vice-Chair of the IUCN Academy of Environmental Law and co-chair of its Teaching and Research Committee. She was Honorary Legal Advisor to the Nature Society Singapore, for many years. She is a member of the Board of Governors, WWF Singapore. She was recently appointed to the Panel of Advisors on Wildlife Issues,

Agri-Veterinary Authority (AVA), Singapore.

She also teaches Property Law and is a member of the Strata Titles Board, and former member of the Tenants Compensation Board and Housing & Development Board (HDB), Singapore.
