PERSONAL DATA PROTECTION ACT

If your application is unsuccessful, NUS may retain and use the information which you provided for 2 years from the receipt of your curriculum vitae and/or personal particulars to deal with any matter which may arise in connection with your application, for purposes of contacting you in connection with ongoing visiting / attachment opportunities, as well as for data analysis and business purposes.
