Students will be allowed to read one **University Research Opportunities Programme / Directed Research (DR)** in their candidature.

3. Compulsory Courses

LC2017 Law and Technology (6 units WEF AY26/27) and LC3001A Evidence (A) (8 units). All Year 3 students will be pre-allocated the Lecture component of LC3001A and LC2017 in Semester 1. Students are to select their tutorial group during the 'Select Tutorial' Round of CourseReg exercise. Students going on exchange in Year 3 Semester 1 will read the courses in Year 4 Semester 1.

GEA1000 Quantitative Reasoning with Data (4 units). All Single Degree Programme Year 3 students will be pre-allocated GEA1000 based on the schedule below and are not required to include the course in the 'Course Selection' Rounds of the CourseReg exercise. However, students are to participate in the 'Select Tutorial' Round of CourseReg exercise to select their preferred tutorial slots.

Priority for LAW Elective Courses

Priority in the allocation of elective courses is set out in the following manner:

Priority 1	a. PhD, GradDipMLA, and UG DDP students. All courses selected will be allocated. b. Specialist LLM students, except LLM (IBL). Priority allocation will be given for up to 15 units (within the areas of specialisations) required to fulfill the specialisation requirement. Priority will be given to students in this category only during Round 1.
Priority 2	a. General LLM, JD, LLB/GLB, Exchange students b. Specialist LLM students selecting courses outside their areas of specialisations.

CourseReg@EduRec 'Select Courses' Rounds

Please note that the total quota for most Law elective courses (across all Academic Careers) is 50, subject to room capacity. Thus, Law elective courses will not be listed in the Vacancy Report on the [CourseReg website](#). Non-Law Elective Courses

The rounds set-up is configured by the course host departments. Year 4 students will have higher seniority score than Year 3 students at all eligible rounds.

7. Before you select your elective courses, please refer [HERE](#) and take note of the following:
 - a. You must adhere to the specific **Prerequisites and Preclusions** of the respective courses. **You are precluded from reading course(s), which are substantially similar to the course(s) you have already completed on exchange.** Students will be required to drop the affected course and make up the units. Where there are doubts concerning courses taken on Exchange and NUS courses that you intend to read, clarification should be sought directly from the respective course convenors with a copy to Office of Academic Affairs at lawundergrad@nus.edu.sg and Student Exchange at lawsep@nus.edu.sg by providing the following details:
 - Student's Full Name and Student Number
 - Host University
 - Course Name
 - Course Description (course details/syllabus, contact hours, number of teaching weeks, etc.)
 - b. There must be **no clashes in class and/or final and take-home exam/assessment timetable**. In addition, you should plan your workload in the semester and be mindful of the number of assignments in each course, the weight the assignments carry and the assignment deadlines.

Students who wish to select non-law courses should check the various platforms (NUSMods, Canvas, course websites, etc.) or consult the course hosts for information on assessments prior to selection to avoid clashes.

9. Important Reminders:

- a. **Academic Plan Declaration** – Please complete the declaration **at least 24 hours before** participating in the course registration exercise. Failure to do so may result in a delay in selection of courses.
- b. **‘Honour’ Declaration for Students Returning from SEP** – Law students who participated in SEP in Sem 2, AY2025/2026 do not need to complete the ‘Honour’ Declaration to upgrade their CourseReg Seniority. Their degree levels have been upgraded in EduRec assuming that full credits will be transferred.
- c. **Negative Service Indicator** – Students who have an NSI for outstanding fees or other reasons will not be able to login to CourseReg@EduRec. It is important that all outstanding fees or medical fitness assessment requirements are settled **at least three (3) working days before** the start of the course registration exercise. Lifting of the NSI is not within the Faculty’s discretion.
- d. **Appeals** – All academic-related appeals must be submitted through CourseReg@EduRec. Course convenors **do not** have discretion to enrol students in their courses. Please do not send any appeals to them.
- e. **Enquiries** – Please email lawundergrad@nus.edu.sg. When corresponding with the faculties and other NUS offices, please do not use your personal email address. Always use your NUS email account and include your student ID (the number on your Student Card) in order for us to verify your identity and better assist you.
