JD students read courses with prefix LCJ5 (compulsory course) and LLJ5 (elective course). Courses in **green** are taught year-long and courses in **blue** are electives. Some compulsory courses must be read in the earlier semesters as they are prerequisites to other courses.

1. Year-long courses are taught over two semesters and the course units will be split across both semesters. Year-long courses must be read from Semester 1 of an academic year.
2. Students must complete at least one Civil Law Elective as a graduation requirement.
  - It is recommended that they read LCJ5010 Legal Systems of Asia (LSA).
  - Students who choose not to read LSA may replace it with a Civil Law Elective but should note that the prerequisites for some Civil Law Electives stipulate the completion of core compulsory courses such as Company Law. Students should consult the Director of the JD Programme when in doubt.
3. Students who have read a Civil Law Elective in Year 2 may read any Law Electives instead.

4. *Students will be automatically enrolled for LCJ5009 Pro Bono Service from Year 1 or 1st Semester of study and are expected to complete the requirements by Year 2 or 4th Semester of study:*
  - *In the first three semesters of study, the course will be graded 'IP' if it remains incomplete or 'CS' upon completion.*
  - *From the 4<sup>th</sup> semester of study, the course will be graded 'CU' if it remains incomplete or 'CS' upon completion.*
  - *Students will not be able to graduate if the course is graded 'CU' by the end of the graduating semester, even if they have completed the other requirements.*
5. *Students are only allowed to complete up to 124 units of courses and will be required to drop any courses in excess.*
