[^] 1. 4-year LLB students are allowed to register for 17-23 credits of courses per semester in the semesters they read elective courses. The total number of credits of elective courses per candidature is a range of 64-68. The total number of credits for the LLB degree including the 98 credits of compulsory courses must fall within a range of 160-164.

2. All students must complete at least one law elective course from "Civil Law" cluster list.

3. Students may read up to 40 units of non-law elective courses.

The limit on the number of Level-1000 courses to be counted towards fulfillment of graduation requirements is 60 units, including compulsory courses.
